

Wildland Urban Interface (WUI) Type 1 Engine Purchase

Summary:

A committee of seven El Dorado Hills fire personnel was selected to put together a specification document to go out to bid for a new Wildland Urban Interface Type 1 engine. This new engine will replace a unit that has been burdened with many maintenance issues and has become unreliable.

In early January, the WUI Engine specifications were sent out to over 15 apparatus manufacturers for a bid opening in the middle of January. We received eight bids as shown below with tax included. Each bid was evaluated for compliance and reference checks were completed on the three low bidders.

The Apparatus Committee has thoroughly researched all the above vendors for service and reliability and have determined that KME Kovatch, Rosenbauer and Smeal meet all specifications. The Apparatus Committee is recommending to award the bid to KME Kovatch who has been building fire apparatus since the 1970's. There are over 200 KME Kovatch apparatus in service in the Los Angeles area and many others throughout the United States. FDNY has recently purchased 55 new pumpers from KME Kovatch.

Fiscal Impact:

\$434,335: The cost of this unit will come out of the Capitol Replacement Fund and \$600,000 has been set aside in the 2012/13 budget. We anticipate that there may be some additional minor build-up costs incurred with customizing this engine to meet El Dorado Hills needs. These additional costs are estimated to be \$20,000 - \$30,000.

Recommendation:

Staff recommends approval to enter into a contract with KME Kovatch to build a new WUI Type 1 Engine with a 300 day build timeframe. 100% payment will be made upon completion and delivery to Station 85 in El Dorado Hills. Note: This payment will not be made until the 2013/14 budget cycle.
