



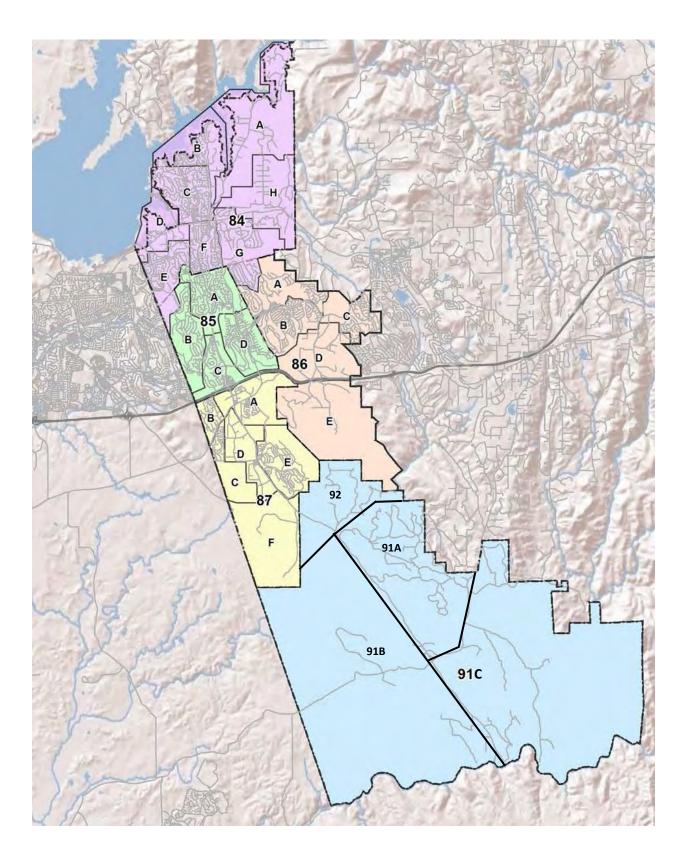

Vacant Lot Program

This program has completed for 2017. Approximately 3,000 lots inspected & under 100 forced abatements and liens over 4 months of time, April – July.

Hazard Reduction Program

Crews are actively inspecting through July 31st. We are continuing to work with the community for complaints and compliance. We field call-in complaints daily, inspect and write up as necessary. Recent fires in EDH have made the public more active in their fire awareness and proper clearances, resulting in more time spent speaking to the community members that call or walk in.

Business Inspection Program

- ➢ 48 activities / 160 personnel / 2,798 staff hours
- The iPads have proved to be a success. Inspections are more consistently thorough and tracking of re-inspections is done with ease on the iPads and FH app system. Compliance in the business community has improved through this program. 84, 85, 86 have completed all of their respective initial inspections, with very few re-inspections to complete. We will continue to monitor the program throughout this first year.

Fire Prevention Officers Meetings

- ➢ 6 activities / 10 personnel / 35 staff hours
- We are now working on the CA Fire Safe Regulations as adopted by the County, as well as revising outdated standards for EDH as well as the Region.
- > Discussing permitting requirements as written in the CA Fire Code.

Fire Safe Councils

- Meetings have begun for 2017, starting in March. Chipping program has been restarted with new grant funding. The Fire Safe Council remains very active and is receiving and filing for grant money on a regular basis. Marshall Cox has assumed a Board Member role on the EDC FSC.

To provide Section 20516 (Employees Sharing Additional Cost) of an additional .5% for classic local miscellaneous members.

The Board of Administration, California Public Employees' Retirement System, hereinafter referred to as Board, and the governing body of the above public agency, hereinafter referred to as Public Agency, having entered into a contract effective October 1, 1978, and witnessed September 20, 1978, and as amended effective December 30, 1986, December 26, 1989, November 21, 1991, January 16, 1992, December 22, 1994, June 26, 2001, July 1, 2002, August 1, 2006, October 22, 2010, September 20, 2011, November 27, 2012 and October 11, 2016 which provides for participation of Public Agency in said System, Board and Public Agency hereby agree as follows:

- A. Paragraphs 1 through 17 are hereby stricken from said contract as executed effective October 11, 2016, and hereby replaced by the following paragraphs numbered 1 through 17 inclusive:
 - 1. All words and terms used herein which are defined in the Public Employees' Retirement Law shall have the meaning as defined therein unless otherwise specifically provided. "Normal retirement age" shall mean age 60 for classic local miscellaneous members entering membership in the miscellaneous classification on or prior to November 27, 2012, age 55 for classic local miscellaneous members entering membership for the first time in the miscellaneous classification after November 27, 2012, age 62 for new local miscellaneous members, age 50 for classic local safety members entering membership in the safety classification on or prior to November 27, 2012, age 55 for classic local age 55 for classic local safety members entering membership in the safety classification on or prior to November 27, 2012, age 55 for classic local safety members entering membership for the first time in the safety classification after November 27, 2012, age 55 for classic local safety members entering membership for the first time in the safety classification after November 27, 2012, age 55 for classic local safety members entering membership for the first time in the safety classification after November 27, 2012, age 55 for classic local safety members entering membership for the first time in the safety classification after November 27, 2012, age 57 for new local safety members.

- 2. Public Agency shall participate in the Public Employees' Retirement System from and after October 1, 1978 making its employees as hereinafter provided, members of said System subject to all provisions of the Public Employees' Retirement Law except such as apply only on election of a contracting agency and are not provided for herein and to all amendments to said Law hereafter enacted except those, which by express provisions thereof, apply only on the election of a contracting agency.
- 3. Public Agency agrees to indemnify, defend and hold harmless the California Public Employees' Retirement System (CalPERS) and its trustees, agents and employees, the CalPERS Board of Administration, and the California Public Employees' Retirement Fund from any claims, demands, actions, losses, liabilities, damages, judgments, expenses and costs, including but not limited to interest, penalties and attorney fees that may arise as a result of any of the following:
 - (a) Public Agency's election to provide retirement benefits, provisions or formulas under this Contract that are different than the retirement benefits, provisions or formulas provided under the Public Agency's prior non-CalPERS retirement program.
 - (b) Any dispute, disagreement, claim, or proceeding (including without limitation arbitration, administrative hearing, or litigation) between Public Agency and its employees (or their representatives) which relates to Public Agency's election to amend this Contract to provide retirement benefits, provisions or formulas that are different than such employees' existing retirement benefits, provisions or formulas.
 - (c) Public Agency's agreement with a third party other than CalPERS to provide retirement benefits, provisions, or formulas that are different than the retirement benefits, provisions or formulas provided under this Contract and provided for under the California Public Employees' Retirement Law.
- 4. Employees of Public Agency in the following classes shall become members of said Retirement System except such in each such class as are excluded by law or this agreement:
 - a. Local Fire Fighters (herein referred to as local safety members);
 - b. Employees other than local safety members (herein referred to as local miscellaneous members).

- 5. In addition to the classes of employees excluded from membership by said Retirement Law, the following classes of employees shall not become members of said Retirement System:
 - a. ELECTIVE DIRECTORS; AND
 - b. POLICE OFFICERS.
- 6. The percentage of final compensation to be provided for each year of credited prior and current service as a classic local miscellaneous member in employment before and not on or after August 1, 2006 shall be determined in accordance with Section 21354 of said Retirement Law (2% at age 55 Full).
- 7. The percentage of final compensation to be provided for each year of credited prior and current service as a classic local miscellaneous member in employment on or after August 1, 2006 and not entering membership for the first time with this agency in the miscellaneous classification after November 27, 2012 shall be determined in accordance with Section 21354.3 of said Retirement Law (3% at age 60 Full).
- 8. The percentage of final compensation to be provided for each year of credited current service as a classic local miscellaneous member entering membership for the first time with this agency in the miscellaneous classification after November 27, 2012 shall be determined in accordance with Section 21354 of said Retirement Law (2% at age 55 Full).
- 9. The percentage of final compensation to be provided for each year of credited prior and current service as a new local miscellaneous member shall be determined in accordance with Section 7522.20 of said Retirement Law (2% at age 62 Full).
- The percentage of final compensation to be provided for each year of credited prior and current service as a classic local safety member entering membership in the safety classification on or prior to November 27, 2012 shall be determined in accordance with Section 21362.2 of said Retirement Law (3% at age 50 Full).
- 11. The percentage of final compensation to be provided for each year of credited current service as a classic local safety member entering membership for the first time with this agency in the safety classification after November 27, 2012 shall be determined in accordance with Section 21363.1 of said Retirement Law (3% at age 55 Full).

- 12. The percentage of final compensation to be provided for each year of credited prior and current service as a new local safety member shall be determined in accordance with Section 7522.25(d) of said Retirement Law (2.7% at age 57 Full).
- 13. Public Agency elected and elects to be subject to the following optional provisions:
 - a. Section 21573 (Third Level of 1959 Survivor Benefits).
 - b. Section 20042 (One-Year Final Compensation) for those classic local miscellaneous members and classic local safety members entering membership on or prior to November 27, 2012.
 - c. Section 21024 (Military Service Credit as Public Service) for local safety members only.
 - d. Section 20903 (Two Years Additional Service Credit).
 - e. Section 21427 (Improved Nonindustrial Disability Allowance).
 - f. Section 21623.5 (\$5,000 Retired Death Benefit).
 - g. Section 21540.5 (Special Death Benefit -- Violent Act).
 - h. Section 21547.7 (Alternate Death Benefit for Local Fire Members Credited with 20 or More Years of Service).
 - i. Section 20516 (Employees Sharing Cost of Additional Benefits):

Section 21354.3 (3% at age 60 Full) for local miscellaneous members. From and after the September 20, 2011 for those local miscellaneous members entering membership on or prior to November 27, 2012 and until October 11, 2016 the miscellaneous employees of Public Agency shall be assessed an additional 3% of their compensation for a total contribution rate of 11% pursuant to Government Code Section 20516.

Section 21362.2 (3% at age 50 Full) and Section 21363.1 (3% at age 55 Full) for local safety members. From and after September 20, 2011 and until October 11, 2016 the safety employees of Public Agency shall be assessed an additional 3% of their compensation for a total contribution rate of 12% pursuant to Government Code Section 20516.

j. Section 20475 (Different Level of Benefits): Section 21354 (2% at age 55 Full) and Section 20037 (Three-Year Final Compensation) are applicable to classic local miscellaneous members entering membership for the first time with this agency in the miscellaneous classification after November 27, 2012.

Section 21363.1 (3% at age 55 Full) and Section 20037 (Three-Year Final Compensation) are applicable to classic local safety members entering membership for the first time with this agency in the safety classification after November 27, 2012.

k. Section 20516 (Employees Sharing Additional Cost):

From and after October 11, 2016 and until the effective date of this amendment to contract, 3.5% for classic local miscellaneous members.

From and after October 11, 2016, 6% for classic local safety members.

From and after the effective date of this amendment to contract, 4% for classic local miscellaneous members.

The portion of the employer's contribution that the member agrees to contribute from his or her compensation, over and above the member's normal contribution ("Cost Sharing Percentage"), shall not exceed the Employer Normal Cost Rate, as that rate is defined in the CalPERS Actuarial Valuation for the relevant fiscal year. If the Cost Sharing Percentage will exceed the relevant Employer Normal Cost Rate, the Cost Sharing Percentage shall automatically be reduced to an amount equal to, and not to exceed, the Employer Normal Cost Rate for the relevant fiscal year.

- 14. Public Agency shall contribute to said Retirement System the contributions determined by actuarial valuations of prior and future service liability with respect to local miscellaneous members and local safety members of said Retirement System.
- 15. Public Agency shall also contribute to said Retirement System as follows:
 - a. Contributions required per covered member on account of the 1959 Survivor Benefits provided under Section 21573 of said Retirement Law. (Subject to annual change.) In addition, all assets and liabilities of Public Agency and its employees shall be pooled in a single account, based on term insurance rates, for survivors of all local miscellaneous members and local safety members.

- b. A reasonable amount, as fixed by the Board, payable in one installment within 60 days of date of contract to cover the costs of administering said System as it affects the employees of Public Agency, not including the costs of special valuations or of the periodic investigation and valuations required by law.
- c. A reasonable amount, as fixed by the Board, payable in one installment as the occasions arise, to cover the costs of special valuations on account of employees of Public Agency, and costs of the periodic investigation and valuations required by law.
- 16. Contributions required of Public Agency and its employees shall be subject to adjustment by Board on account of amendments to the Public Employees' Retirement Law, and on account of the experience under the Retirement System as determined by the periodic investigation and valuation required by said Retirement Law.
- 17. Contributions required of Public Agency and its employees shall be paid by Public Agency to the Retirement System within fifteen days after the end of the period to which said contributions refer or as may be prescribed by Board regulation. If more or less than the correct amount of contributions is paid for any period, proper adjustment shall be made in connection with subsequent remittances. Adjustments on account of errors in contributions required of any employee may be made by direct payments between the employee and the Board.

RESOLUTION NO. 2017-24 EL DORADO HILLS COUNTY WATER DISTRICT RESOLUTION OF THE BOARD CONFIRMING THE REPORT OF THE FIRE MARSHAL RELATED TO COST OF WEED ABATEMENT AND IMPOSING SUCH COSTS UPON PROPERTIES UPON WHICH ABATEMENT HAS OCCURRED

WHEREAS, the El Dorado Hills County Water District Board (Fire Department) has the authority pursuant to Section 13879 of the Health and Safety Code to declare weeds a public nuisance and abate said weeds; and

WHEREAS, pursuant to the terms of said weed abatement program, the El Dorado Hills County Water District (EDHCWD) has provided notice to individual property owners declaring that weeds existing upon the identified properties constitute a public nuisance and providing the property owner with notice to abate said weeds within a specified time period; and

WHEREAS, said notices to property owners informed the subject property owner(s) that in the event the subject weeds were not abated within the time frames set forth in said notices, the El Dorado Hills County Water District would, pursuant to the authority granted to it by the Health and Safety Code, contract for the abatement of said weeds with the cost thereof incurred by the Fire Department constituting a special assessment against the property from which removal occurs; and

WHEREAS, the required abatement did not occur on certain properties more fully described in "Exhibit A" attached hereto, and the District contracted for the abatement of said weeds as set forth in its weed abatement program and in the notices to property owners; and

WHEREAS, the cost of the District's abatement of individual lots, including a seventy-five dollar (\$75.00) charge per abated lot for investigation, boundary determination, contracting, clerical and related costs as authorized by Health and Safety Code Section 14912, is detailed in the Report attached hereto, which Report must be approved by the Board prior to transmittal to the County Auditor's Office for collection; and

WHEREAS, the Report has been prepared as required by the governing statutes and posted for the requisite period;

NOW, THEREFORE, the District resolves as follows:

The Report required by Health and Safety Code Sections 14910 and 14911, having been properly prepared and posted for the requisite period, is hereby approved. The Fire Marshal is hereby directed to transmit a copy of said Report to the Office of the County Auditor Controller for purposes of collection of the costs of abatement of the respective properties referenced therein. The District submits to the Auditor Controller the costs of abatement for the attached parcel numbers which shall be included as a separate item on each tax bill of each such parcel and shall be collected at the same time and manner as County property taxes are collected as set forth in the applicable provisions of the Revenue and Taxation Code, and shall be subject to the same penalties and the same procedure and sale in the case of delinquency as provided for such taxes. All laws applicable to the levy, collection, and enforcement of County property taxes shall be applicable to each tax.

Temporary (One Time) Adjustment to Approved Positions List

Summary:

El Dorado Hills Fire Department currently has three (3) Firefighter/Paramedic Positions open that we have recently recruited for. With the testing complete we now have a list of qualified candidates ready for background checks and medical testing.

While we currently have approval to hire for the three (3) open positions your Fire Department Administration is recommending a temporary increase to the Firefighter/Paramedic ranks of two (2) in our approved positions list allowing us to hire a total of five (5).

The reasons for this temporary authorization are multiple, including;

- 1. Potential retirements in the near future (2017 to early 2018)
- 2. Currently two (2) personnel out on long term leave with unknown return dates
- 3. Multiple mandatory overtime assignments
- 4. Summer Strike Team Assignments
- 5. Summer vacation schedules
- 6. The uncertainty with the probationary period for new hires
- 7. Running one "mini-academy" for a greater number of Firefighter/Paramedics = Greater efficiency

Fiscal Impact:

Considering that these positions would be hired at the lower cost rank of Firefighter/Paramedic 1 and most likely in the PEPRA (Public Employee Pension Reform Act) retirement group, and figuring that they would be alleviating an overtime each day they work which is currently filled on average by a more expensive employee at time and a half (150% of wage) the cost if any to the district would be minimal, and offset by the saving of overtime.

Once attrition brings the total number of employees back down to the current number of approved positions this temporary two (2) position increase would expire.

Recommendation:

Authorize a temporary (one-time) increase to the Approved Positions Listing by Two (2) Firefighter/Paramedics.

Request for approval to surplus staff vehicle 8546

Summary:

8546 is a 2003 Ford Expedition with excess of 125,000 miles. This vehicle has fallen outside of the department replacement schedule by four years and 25,000 miles. Mechanical problems and the cost of keeping it fire department response ready outweigh its usefulness.

8546 has been given the status as an extra department vehicle due to the high mileage and age.

While the vehicle has fallen outside of our replacement schedule, it does have use to other departments with less means. The Department has received requests for any surplus staff vehicles from other local departments. These departments are working on very limited budgets and do not have the ability to purchase a new or used vehicles without severely impacting their budget.

Fiscal Impact:

Revenue from sale expected. Minimal, less than \$1000.

Staff Recommendation:

Surplus staff vehicle 8546 to another fire department in the region at little to no cost.

Replacement of Staff Utility Vehicle

Summary:

Staff received a state contract bid from Folsom Lake Chevy for a 2018 Chevy Silverado 4x4 Police Package. The Department needs one staff vehicle to replace the current vehicle that has an excess of 125,000 miles each. This vehicle will replace 8549, putting 8549 into reserve status.

The new vehicle is specified as a 2018 Chevy Silverado 4x4, capable of transporting five passengers. This vehicle will be configured as command vehicle capable of command functions in emergency situations in county and have the capability to transport staff and equipment.

Folsom Lake Chevy is the sole provider for this type of vehicle within the El Dorado Hills/Folsom region. This vehicle is built for use in a public service realm with larger brakes, standardized wiring for lighting packages, and with the ability to delete unnecessary accessories.

Fiscal Impact: \$80,000.00


State Bid with deductions from Folsom Lake Chevy's price per vehicle is \$37,871.63 plus license.


Installation and cost of emergency equipment not to exceed \$42,128.37 from a separate vendor including tax.
