



# **Incidents by District/Zone**





January 1, 2024 – January 31, 2024





Response times standards are designed to ensure a quick response to the public's request for assistance is achieved. The times listed above are raw, in that, they do not reflect "accepted reasoning" for the delay. At the end of each month, exception reports are filed with the County of El Dorado (Local EMS Agency) by the Department for incidents that are outside the established response time parameters. The reports provide the reasoning why the ambulance did not respond in a timely manner. These reports are then reviewed by the Local EMS Agency and either accepted or denied.

Examples of acceptable reasoning are, but not limited to, weather delays, incorrect address, patient left scene, road construction, incident downgraded in severity requiring no lights/siren (Code 3), etc. Once a decision has been made whether a reason is valid or not, the percentage may be adjusted.



# Operations

A couple of Operational highlights in January 2024:

This month we hired six (6) new Paramedics. They completed a weeklong orientation with administration and operations staff. Following their orientation, all six paramedics successfully completed their El Dorado County accreditation process which allows them to work as paramedics in El Dorado County. They are now finishing up a 4-week "on the job" training plan where they each work with senior firefighter-paramedics before being assigned to work together on Medic 86.

El Dorado Hills Fire participated multiple times in staffing up extra equipment for the rainstorms that hit Northern California in January. We staffed up an extra Type III engine as well as multiple Task Force Leader assignments.


#### **Incidents**

- Rescue 85 will be FIRESCOPE Typed as a Medium (Type 2) Rescue.




Dynamic Water Rescue







## **Training Update**

This month, all shifts participated in individual and multi-company training 1 ¾" preconnect hose deployment and 3" to 1 ¾" bundle deployment. B and C shift personnel completed the 2 ½" minute man hose loading and deployment with Captain Baldwin and Firefighter Dennis. Crews also completed the online Auto Extrication refresher training assigned to them through Target Solutions. Mandated annual physicals were conducted at Kaiser Occupational Health throughout the month.

**Company Training:** This month, all shifts participated in multi-company drills practicing hose deployments with the 1 ¾" pre-connect hose loads and the 3" to 1 ¾" bundles. B and C shifts completed their required 2 1/2" minute man loads and deployment training with Captain Baldwin and Firefighter Dennis. Crews practiced different techniques in deployment from the rear of the engine to hose management inside of a structure. Water application utilized the 75 psi at 250 gpm combination nozzle and the smooth bore nozzle 50 psi at 250 gpm.

**EMS Training:** None assigned this month

Mandate Training: Annual Medical Testing/Hearing, DMV Physicals

**Captain's Corner:** All crews have been advised to contact Training Captain Smith to schedule command and control simulator training at the CTC. Training will begin when Recruit Fire Academy has concluded. Training will include size-ups and initial assignments as well as incident priorities, strategy, and tactical objectives.

**Building Walk-through:** Crews have been instructed to identify and tour residential target hazard buildings in their first-due areas of assignment. Crews should identify access, egress areas of concern, and fire suppression tactics.
